

Privacy Policy

The protection of your personal data is very important to us. Therefore, we process your data exclusively on the basis of the legal regulations (GDPR, Austrian Data Protection Act 2018, Austrian Telecommunications Act 2003). In this privacy statement we inform you about the most important aspects of data processing within the framework of our company and our websites.

Appropriation, legal basis, duration of storage, data receiver

We need the collected personal data for contract fulfilment, accounting, assertion of contract claims, for the purpose of customer service as well as for the fulfilment of legal obligations. The data is collected, stored, processed and used for this purpose.

The legal basis for the processing of your personal data is contract fulfilment, legitimate interests, the fulfilment of our legal and contractual obligations as well as your consent (e.g. contact form, newsletter, cookies). The non-provision of data can have different consequences.

We process your personal data as far as is necessary, for the duration of the entire business relationship and beyond, in accordance with the statutory storage and documentation obligations arising, inter alia, from the Austrian Commercial Code (UGB) and the Austrian Federal Tax Code (BAO), as well as until the end of any legal dispute, continuous warranty and guarantee periods, limitation periods, the maintenance or enforcement of rights, etc.

If you use our online shop, we would like to inform you that only the data that you give us in the course of the order will be stored by the online shop operator for the purpose of the contract.

Without this data we cannot conclude the contract with you.

By cancelling the shopping process in the online shop, you prevent the storage of data.

For the operation of our websites, we commission IT and payment service providers, who in the course of their activities can gain access to your personal data, as long as they need the data to deliver the respective service. They have committed themselves to complying with the applicable data protection regulations.

Contract processing contracts have been concluded in accordance with Art. 28 GDPR. You can request further information on the order processors commissioned by us at datenschutz@steka.at.

In addition, further data may be stored by us. We only collect data which is absolutely necessary for the fulfilment of the contract or for the implementation of pre-contractual actions.



Your personal data will be forwarded to the lowest possible extent, if this is absolutely necessary for the fulfilment of the contract, the fulfilment of legal provisions and the assertion of rights. As recipient categories, the following can be considered in the case in question:

Participating contract and business partners (e.g. shipping partners and IT service providers)
Commercial agents in your country
Banks and payment service providers
Third part lenders (e.g. in the case of leasing)
Tax consultants and auditors
Authorities
Legal representatives
Collection agencies
Courts

Data will only be transmitted to a non-European third country without your express consent in the case of a commercial agency in your country, on the basis of standard contractual clauses or an adequacy decision of the European Commission.

Cookies

Data security

Your rights

In principle, you have the rights to disclosure, correction, deletion, restriction, data portability, revocation and objection. In Austria, this is the Austrian Data Protection Authority (Datenschutzbehörde).
